Application Guideline for Proposing the Concession PFI Project for Ariake Arena (Overview)

Application Guideline for Proposing the Concession PFI Project for Ariake Arena (Overview) is the brief description distributed to the applicant (an applicant or a group applicant) over the selection process of the concessioner (the facility operator) by Tokyo Metropolitan Government (hereafter the "TMG") under the "Act on Promotion of Private Finance Initiative". (hereafter "PFI Act")

For the details please refer to the application guideline and other documents which is integrated with the application guideline; demanding standards, selection criteria, basic agreement (tentative) and contract (tentative). (*All materials are in Japanese.)

Please note all of the procedures concerning the application and selection of the concessioner and other contract procedures will be done in Japanese.

Section 1. The purpose and contents of the Concession PFI Project

After the Tokyo 2020 Games, Ariake Arena will aim to serve as a new hub for sports and culture in Tokyo by creating a movement toward active participation in sport through providing opportunities for the public to watch high-quality sports games including international competitions and providing culture and entertainment by hosting events such as concerts.

The Concession PFI Project (facility management and operation) for Ariake Arena will target to improve services and create a worthy legacy for the Tokyo residents which relies on the knowledge and ingenuity of the private sector to the fullest extent. Moreover, it will mitigate the burden on the Tokyo residents through securing facility profitability and concession fee by implementing a concession PFI under the PFI Act for public facility management and operation.

The Concession PFI Project period is composed of the following periods; preparation period, facility maintenance period, and facility operation period. The facility operating rights will dissolve on the termination date of facility operation period. The rights will not be extended in principle.

In addition, the assembly's resolution concerning the concession rights granted is scheduled to be decided in June 2019.

Section 2. Fee Proposals

The concessioner will be required to pay concession fee (Fixed fee and Performance Linked Fee.)

The concession fee can be paid separately through the facility operation period. No payments will be charged at the beginning of the operation period.

1. Fixed fee

The required amount will be the same every year without interest in principle

regardless of the performance of the concessioner.

2. Performance Linked Fee

Concessioner should propose Performance Linked Fee which is linked with profit.

The proposal of the Performance Linked Fee should exceed 20 % of current pretax net profit after payment of Fixed Fee.

3. Reference costs of Fixed Fee

Reference costs of Fixed Fee paid to the TMG during the facility operation period by the concessioner is as follows.

Reference costs: JPY 6.4 billion (Total amount during the facility operation period including consumption tax and local consumption tax.)

The applicant should propose the Fixed Fee which is equal to or more than the reference costs.

Section 3. Requirement of the applicant.

1. The composition of the applicant

"The applicant" in this document is defined as a firm (an applicant) or an assembly of multiple firms (a group applicant)

2. Selection of representative firm

In cases where a group applicant applies, select a representative firm within the group. In addition, specify the name of representative firm when submitting application and the representative firm should proceed the application procedures.

3. Prohibition of overlapping participation

Those related to the applicant, members of the group applicant*'or partner firms*² in capital or in personnel should not be allowed to participate as the other applicant, members or partner firms.

*Note1: Firms which compose the applicants and invest for SPC

*Note2: Firms which partially undertake operation works of the concessioner directed in the demanding standards, although neither of them are members of the applicants nor investing for SPC

4. Common prerequisites for the applicant, members and partner firms

The following prerequisites are common for all the applicant, members and partner firms.

- a. Should not apply with enforcement of local Autonomy Act Article 167-4 paragraph 1 and 2.
- b. Should not apply with either of the issues of PFI Act Article 9.
- c. Should not be in the designated suspension period based on the guideline for the qualification for participating in the tendering procedures.
- d. Should not be in a situation with financial difficulty.
- e. Should not fail to pay Tokyo Municipal tax, corporation tax, and consumption tax etc. in the nearest year.
- f. Should not be a person in eliminating period based on Act for the Prevention of Wrongful Acts by Members of Crime Groups, Article 5 paragraph 1.
- g. Should not belong or directly involved to a group subject to punishment against Act on the Control of Organizations Which Have Committed Acts of Indiscriminate Mass Murder Article 8 paragraph 2(i).
- h. Should not apply with the local Autonomy Act Article 92-2 and Article 180-5.
- i. Should not be a person or associated company concluding an advisory contract with the TMG for this Concession PFI Project.
- j. Should not be a member of selection committee and firm, group or associated company which the committee member belongs to.

5. Common prerequisites for the applicant or representative firms of a group applicant.

The following prerequisites are common for all the applicant and representative firms of a group applicant.

- ·Having a qualification for participating in the tendering procedures at the TMG for purchasing goods during fiscal 2017 and 2018.
- •Obtaining a qualification for participating in the tendering procedures at the TMG for purchasing goods during fiscal 2019 and 2020.

Section 5. Contract procedures

1. Conclusion of basic agreement

After deciding the candidate, promptly conclude the basic agreement between the TMG and the candidate.

2. Establishment of SPC (Special Purpose Company)

The candidate should establish the SPC as a stock company set in Companies Act before concluding the provisional contract with the TMG. The SPC should be established in the Tokyo Metropolitan area and the fiscal year of the SPC should be

between April 1st to March 31st of the following year.

3. Conclusion of the provisional contract

The TMG and the candidate will promptly conclude the provisional contract after

the SPC establishment based on the basic agreement provision in order to submit

the bill concerning the concession rights at the second regular session of Tokyo

Metropolitan Assembly in 2019.

4. Conclusion of facility operation contract

The TMG and the candidate will conclude the facility operation and management

contract including concession rights after the bill approved by the second regular

session of Tokyo Metropolitan Assembly in 2019.

5. Others

Language and currency used in the contract procedures should only be done in

Japanese and currency of Japan.
